CONTEST RULES AND REGULATIONS

- The contest entry fee is \$20 for Knee Deep Club Members and \$25 for non-members (\$20 entry fee + \$5 non-member fee) and must be submitted with the official contest entry form below. The contest will begin at 5 A.M on Saturday, September 17th and will conclude at 2 PM on Sunday.
- 2. Mailed entries must be received by the Club by Friday, September 16th, regardless of postmark. In-person entries can be made at either official Knee Deep Club Contest Weigh Stations until 8 AM, Saturday, September 17th. No one will be allowed to register after this time. NO EXCEPTIONS.
- 3. Official Contest Weigh Stations are DOW'S BOAT RENTAL, Nolan's Point, Lake Hopatcong & LAKE'S END MARINA, Lakeside Blvd., Landing.
- 4. Cash prizes will be based on an 80% payback of entry fees. The winners will be the top three anglers who score the highest points based on the following point system. Five (5), Three (3) and Two (2) Points will be awarded for 1st, 2nd and 3rd Place fish in the following seven categories: Walleye, Trout (all species), Channel Catfish, Largemouth Bass, Smallmouth Bass, Hybrid Striped Bass and Pickerel. Three (3), Two (2) and One (1) Points will be awarded for 1st, 2nd and 3rd Place fish in the following four categories: Catfish (other than Channel Catfish), White Perch, Yellow Perch and Crappie.
- 5. Top finishers will be based on points and any ties will be broken by which fish was entered first. In the event of a tie in total points, the angler that has the single largest fish will win. Anglers will only be allowed to place one fish in each category but can continue to enter fish to improve their standings.
- 6. A contestant may win ONLY ONE PRIZE.
- 7. Contestants may enter fish caught in Lake Hopatcong ONLY!
- 8. All persons in a boat must be entered in the contest to qualify for prizes. Contestants may fish any or all parts of this contest.
- 9. All fish may be weighed-in during contest hours. Any disputes must be resolved at the time of the weigh-in. The decision of the Contest Committee will be final and binding! The Weigh Master has the right to retain, cut open or inspect any fish.


