CONTEST RULES AND REGULATIONS

- 1. The contest entry fee is \$20 for Knee Deep Club Members and \$25 for non-members (\$20 entry + \$5 non-member fee) and must be submitted with the official contest entry form below. The contest will begin at 5:00 AM on Sunday, June 26 and will end at 4:00 PM.
- 2. Mailed-in entries must be received by the Club on Friday, June 24 regardless of the postmark. In-person entries can be made at either official Knee Deep Contest Weigh Station until 8:00 AM on Sunday. **No one will be allowed to register after this time. NO EXCEPTIONS.**
- 3. **CASH PRIZES** will be based on an 80% payback of entry fees for the three (3) heaviest Largemouth Bass or Smallmouth Bass weighed in for this contest. In addition to the cash prizes, Rod & Reel Combos donated by Ramsey Outdoor will be awarded to the individuals who placed 1st, 2nd & 3rd.
- 4. BONUS PLAN participants for this contest will have their cash prizes increased by 25%.
- 5. **GIFT CERTIFICATES:** The anglers weighing in the 4th, 5th & 6th heaviest Largemouth or Smallmouth Bass will receive a \$20 Gift Certificate from Ramsey Outdoor.
- 6. A contestant may only win one prize. If any of the Prizes are not awarded, the prize money will go to the club's stocking fund.
- 7. Top finishers will be based on weight and any ties will be broken by which fish was weighed in first.
- 8. Only Largemouth Bass or Smallmouth Bass caught in Lake Hopatcong may be entered. Bait may be used in this Bass Contest.
- 9. All persons in a boat must be entered in the contest to qualify for prizes. Contestants may fish any or all parts of the contest.
- 10. All fish must be weighed-in during contest hours. The Weigh Master has the right to retain, cut open or inspect any fish.
- 11. Any disputes must be resolved at the time of the weigh-in. The decision of the Contest Committee will be final and binding.
- 12. The Official Contest Weigh Stations are DOW"S BOAT RENTAL at Nolan's Point and LAKE'S END MARINA on Lakeside Blvd. in Landing.
- 13. **TAKE A KID FISHING:** A contestant may enter a child who is under age 16 in this contest for a \$5 entry fee. The child with the largest fish will win a Rod & Reel Combo. Ties will be broken by which fish was weighed in first.


