

# LAKE HOPATCONG KNEE DEEP CLUB ICE FISHING CONTEST

SUNDAY, FEBRUARY 1, 2026

## RULES AND REGULATIONS

1. Check the Knee Deep Club Web Site or call Dow's Boat Rental at 973-663-3826 to confirm the date of each contest.
2. The contest entry fee is \$20 for Knee Deep Club Members and \$25 for non-members (\$20 entry + \$5 non-member fee) and must be submitted with the official contest entry form below.
3. The contest will begin at 6:00 AM on Sunday and will end at 4:00 PM.
4. Mailed-in entries must be received by the Club by Friday before the contest, regardless of the postmark. In-person entries can be made at either official Knee Deep Club Weigh Station until 8:00 AM on the day of the contest. **No one will be allowed to register after this time. NO EXCEPTIONS.**
5. The Official Contest Weigh Stations are **DOW'S BOAT RENTAL** at Nolan's Point, **LAKES END MARINA** in Landing, and **WEST SHORE MARINE** in River Styx.
6. **CASH PRIZES** will be based on an 80% payback of entry fees for each of these three categories: Perch/Crappie, Pickerel and "All other Species (excluding Muskies)". A cash prize will be paid for the three heaviest fish in each of these categories.
7. Top finishers will be based on weight and any ties will be broken by which fish was weighed in first. A contestant may only win one prize in each category. If any of the Prizes are not awarded, the prize money will go to the club's stocking fund.
8. **Only fish caught through the ice on Lake Hopatcong may be entered. NO FROZEN FISH WILL BE WEIGHED IN.**
9. Contestants may fish any or all parts of the contest. All fish must be weighed-in during contest hours. No fish will be weighed in after 4:00 PM.
10. Any disputes must be resolved at the time of the weigh-in. The decision of the Contest Committee will be final and binding. The Weigh Master has the right to retain, cut open or inspect any fish.
11. **TAKE A KID FISHING:** A contestant may enter a child who is under age 16 in this contest for a \$5 entry fee. The child with the heaviest fish in each category will win a jigging rod and reel. Ties will be broken by which fish was entered first.
