# KNEE DEEP CLUB'S 2022 BONUS PLAN

## Rules & Regulations

1. Mailed-in entries for the **BONUS PLAN** must be received by the Club by Friday, April 22, 2022, regardless of the postmark. Entries can be made in person at either official Weigh Station until 8:00 AM Sunday, April 24, 2022. No one will be able to register for the Bonus Plan after this time. **NO EXCEPTIONS.**
2. **WEIGH STATIONS:** The Official Weigh Stations are **DOW'S BOAT RENTAL** and **LAKE'S END MARINA.**
3. There will be no refunds (full or partial) unless a contest is cancelled by the Club. If a contest is rescheduled, the participant has the option of fishing or receiving a refund for that contest. A request for a refund must be received by the Club by the Friday before the rescheduled contest regardless of the postmark.
4. You can choose to enter 5, 6, 7 or all 8 single species contests. Indicate which contests you decide to enter on this form.
5. Cash prizes will be based on an 80% payback of entry fees for the three heaviest fish for the species in that contest.
6. Prizes will be based on weight. Any ties will be broken by which fish was weighed in first.
7. **If you are in the Bonus Plan, your cash prize for 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> place will be increased by 25%.**
8. If you place 4<sup>th</sup>, 5<sup>th</sup> or 6<sup>th</sup> in any of the contests, you will be eligible to receive the gift certificate to be determined for each contest. There is NO Cash Bonus for 4<sup>th</sup>, 5<sup>th</sup> or 6<sup>th</sup> place.
9. Contestants may **ONLY** enter fish which were caught in Lake Hopatcong.
10. All fish must be weighed-in during normal weigh station hours. Any disputes must be resolved at the time of the weigh-in. The decision of the Contest Committee will be final and binding. The Weigh Master has the right to retain, cut open or to inspect any fish. A contestant may win only one prize in each contest.
11. No fish will be weighed in after the scheduled ending times. **NO EXCEPTIONS.**
12. The Bonus Plan is only open to Knee Deep Club Members. Add \$25 to the fee and check here [     ] if you would like to become a Knee Deep Club member.
